

Get Repairs & Respect NOW!



We, the Justice For All Coalition, are supporting residents in getting repairs now, and holding NYCHA accountable together.

✔ Step 1: Document your needs and efforts to get repairs made.

Submit work tickets & Call 311 — and record the date and time of submission, and the ticket numbers.

Option 1: Keep a separate notebook and/or folder for documents and notes.

Option 2: Take a screenshot of the ticket and store it in a specific folder on your phone. The ticket number will be in the image, and the date and time will be attached to the image as metadata.

} **OR BOTH!**
It is good to have a back-up!

✔ Step 2: Submit a formal letter of complaint via <https://app.justfix.nyc/p/j4ac>

JustFix.nyc is an organization creating digital tools to support tenants in knowing and exercising their rights. They have a tool that helps residents submit a formal letter via USPS Certified Mail to your landlord for free, outlining your repair needs and requesting they attend to them.

✔ Step 3: Notify your elected officials.

When submitting a formal letter of complaint, you can include your elected official as a recipient of this letter. You can also call or email them directly to make sure they know about your needs.

It is their job to represent you. If you need to, you can remind them of this.

✔ Step 4: Attend a tenant meeting.

Every month, JFAC has tenant meetings that bring together residents from across Western Queens to discuss what additional steps you can take as an individual, and how we can work together to get repairs made and hold NYCHA accountable.
